
WHEREAS, the Pierce County Fire District 18 Board of Fire Commissioners has declared the following items surplus to the needs of the department, and

When surplus, obsolete, or unused material, property or equipment is identified submit Form 6003.1 to the Fire Chief or designee which declares the property or equipment surplus, with a brief description, including model/serial numbers, fixed asset numbers, quantity, estimated value and recommended disposition when applicable.
